

Portland Children's Levy – WebGrants Registration Guide

What is WebGrants?

WebGrants is the grants management system for the City of Portland. If you want to apply for a Portland Children's Levy grant, you will need to register in WebGrants and submit your application through the system.

WebGrants will track your application and all related documents for your organization. Multiple people can register under your organization and work on the same grant application in web grants.

Important: Please register as a WebGrants user right away. PCL staff will have to approve your registration before you can access the grant application questions. Staff approval should take 24-48 hours. The deadline to register is **November 14, 2025**.

Who should register?

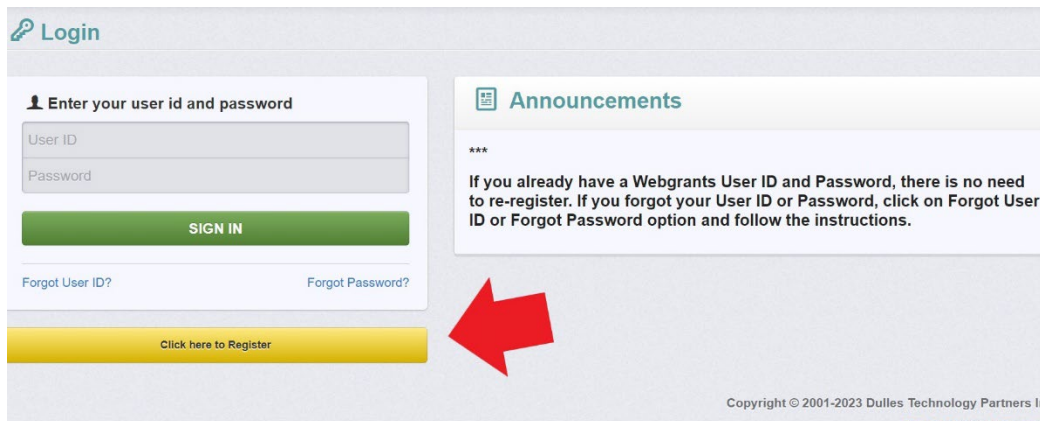
All members of your organization who will create, edit, review, or upload documents for your application should register as a user. A person who is authorized to submit grant applications should register so they can submit the final application.

If you have already registered in WebGrants for a different bureau's grant process (e.g., the Portland Clean Energy Fund or the Office of Violence Prevention's Gun Violence Reduction Program) you do not need to re-register, you can use your existing account.

How to register

Using a computer, go to <https://cityofportlandgrants.net/> in any web browser. WebGrants does not work well on a phone.

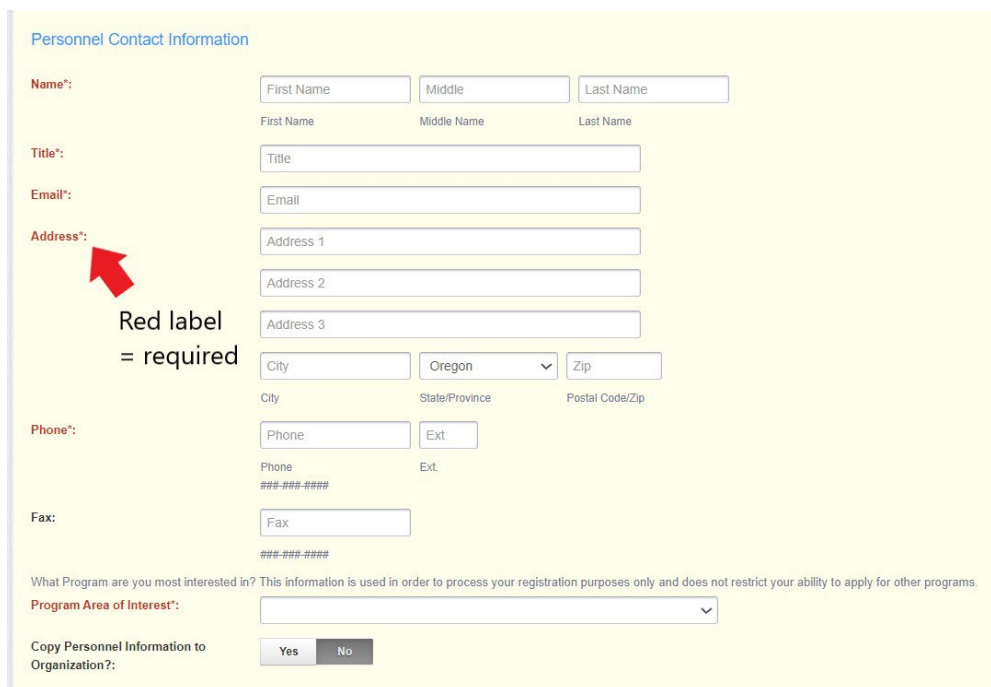

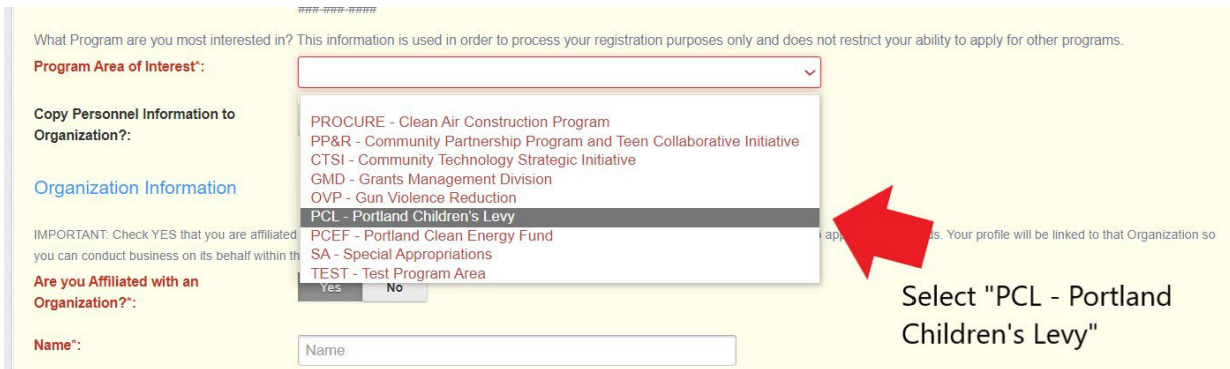

Red label = required

- Email – please carefully enter your email address. All WebGrants correspondence, including your login and password information, will be sent to the email address you enter here.
- Program area of interest – this is a drop-down menu with several options for City grant programs. You must select Portland Children’s Levy so PCL staff receive a request to approve your registration. Choosing Portland Children’s Levy on this menu will not restrict you from applying to any other City of Portland grants in the future. Once your registration is approved you will be able to see all available grant opportunities for the city.

- Affiliation - You must check “yes” on “are you affiliated with an organization?” to enter your organization’s information below. Your application will exist in the organization’s record, and your profile’s affiliation with the organization record is how you access the grant application and related documents. Individuals who are not affiliated with an organization cannot access WebGrants and submit an application for PCL funding.

IMPORTANT: Check YES that you are affiliated with an Organization and enter the details for the Organization you represent which intends to apply for grant funds you can conduct business on its behalf within this grant system.

- Organization name: Please spell out the organization's name instead of only using acronyms. You may also include acronyms if your organization is commonly known this way - example: Portland Children's Levy (PCL)
- Organization Type: Select the organization type that applies to your organization. If you are not sure of the answer, select "non-profit organization".
- Tax ID: This is your federal EIN or Tax ID number found on your 501(c)(3) IRS letter. If you do not know this information, please enter "N/A". PCL staff can update this information later.
- Organization website: This field is optional. If you do enter information, the system will only accept answers that start with "http://" as valid. We recommend you either copy and paste your website from your browser's address bar or leave this field blank.

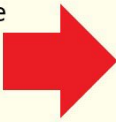

Once PCL staff approves your registration, you will receive an automated email from WebGrants with your login and password. Then you may login to WebGrants and begin your PCL grant application.
